Sr. No. 10, 12, 15, 16, 19, 20, 21, 23, 27, 32, & 34 are eligible for all facilities on transfer account.

The LP(G)s who are now working as CCOR, will be promoted on Proforma basis.

Sr. No. 11, 12, 17, 20, 26, 29, 30 & 31, are promoted against SC roster point.

Sr. No. 32, 33, 34 & 35 are promoted against ST roster point.

Fixation of pay on promotion will be regulated as per recommendations of VII th pay commission. The above employees can exercise an option for fixation of pay within a period of one month as per extent rules.

The above promotion is subject to the conditions that the employee is not undergoing any punishment under DAR/SPE/VIG and no cases are pending nor contemplated against him. If above named employee comes under such punishment, he should not be promoted under advice to this office.

If any of the above employees has been granted financial up gradation under MACP scheme if due he will not be eligible for fixation of pay on promotion.

As per Railway Bd's letter no. 2016-E (SCT) I/25/8 dt. 30.09.2016 (RBE No.117/2016) all further promotions of reserved category persons to unreserved posts are made by ignoring Railway Bd's RBE No.126 dt. 01.09.2010 which in turn was based upon the DOP&T's OM dated 10.08.2010 & under reference No. (i) & (ii) above. However all promotions order henceforth shall be subject to outcome of the main SLPs and above mentioned contempt petition which are still pending.

The above promotion order is provisional, subject to outcome of pending cases in various CATs, High Courts and Supreme Courts.
