Sub:- Re-engagement of retired staff on monthly remuneration basis in Non-Personnel /Mech Department.

Sk. Zubeda Begum.is considered for posting in Clerk under SSE(C&W) WD with following terms and condition.

- She will shall not independently clear the file and letters. She has to route the file or letter through SSE(C&W)WD SUR only.
- She will not exercise any financial powers.
- She will work in General shift and outdoor also if required.
- Six days working week with Rest on Sunday shall apply.
- No leave to be applicable. Only General Holiday can be availed.
- Her salary to be changed to PU-32 under contractual wages..
- IPAS account to be generated afresh under contractual staff category..
- She will act under the general Supervision of the cadre SSE(C&W)WD and violation of conduct rules shall invite termination Proceedings.

These terms and conditions may be got noted by both the candidates as well as the Supervisors.



The retired employees will be re-engaged on monthly remuneration basis with following General terms and conditions.

- This re-engagement is to be reviewed at the interval of every year effective from 1st January of the year.
- The scheme is valid up to 01/12/2019.
- The administration is at liberty to terminate the services of the re-engaged employees even before 01/12/2019 in case their work/conduct is found unsatisfactory by giving a notice of 07 days
- The re-engaged employee is entitled only for monthly fixed remuneration i.e. reducing pension from his last pay drawn, (i.e. Basic + DA as applicable) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay drawn at the time of retirement.
- The re-engaged employee will not be eligible for any kind of leave (like CL, APL, and Sick Leave etc.) For absence if any, appropriate deduction will be made from the monthly remuneration.

6. The duty hours of the re-engaged employees would be as per requirement. The duty hours can be changed as per the requirement of work by the administration.
7. The re-engaged staff will not have any claim or right for his continuity in service or automatic extension or termination of contract.
8. The service condition of re-engaged retired employees will be governed by Railway Board guidelines issued from time to time.
9. Re-engaged staff should be discharged immediately on joining of selected candidates.

The above named Retd. Employee is re-engaged up to **01.12.2019** and administration is at liberty to terminate their services of the re-engagement in case her work/conduct is found unsatisfactory by giving a notice of 07 days
