*However being a non-safety category and there is one vacancy of "ST" community, following one "ST" employee i.e. Shri Mahesh Kumar Meena (ST) is proposed under "Best Among Failed Policy", as per Rly. Boards letter No. E(ECT)1/23/1 dtd. 08.05.1989. He is promoted on adhoc basis for six months. During these six months period he should be given all facilities for improving his knowledge and coming up to the requisite Standard. At the end of six months period a decision has to be taken by the competent authority based on his working report, whether his name can be include in the panel or otherwise.

The above named will have to appear and qualify in the typing test within 02 years from the date of promotion as Jr. Clerk cum Typist GP Rs. 1900/- (Level-2) failing which they will be reverted . Typing test will be of typing speed of 30 w.p.m in English or 25 w.p.m in Hindi. As per Railway Board's letter No. E(NG)I-2004/CFP/8 dated 04.07.2005, it has been decided that instead of testing the typing skill on typewriters, the same may be tested on personal computers (PCs) at the speed of 40 w.p.m in English or 35 w.p.m. in Hindi

The above promotion order is provisional and subject to the conditions, that they are no DAR/SPE/Vig cases pending and not undergoing any penalty debarring promotion which should be ensured by the supervisor/official concerned before the promotion is effected. The promotion is also subject to disposal of writ petitions / appeals / applications pending in Honorable Supreme Court / High Court or CAT as the case may be. The employee is eligible to draw higher rate of pay in the promoted grade from the date they shoulder higher responsibility. Pay fixation will be done as per Para 13 of RS(RP) Rules 2016. The Date of shouldering higher responsibilities of the employee should be advised to all concerned without fail.
