Sub :- Re- engagement of retired staff on monthly remuneration basis in C&W Deptt.

Terms & Conditions of Re- Engagement

- 1. This re-engagement is to be reviewed at the interval of every year effective from 1st January of the year.
- 2. The scheme is valid up to 01/12/2019.
- The administration is at liberty to terminate the services of the re-engaged employees even before 01/12/2019 in case their work/conduct is found unsatisfactory by giving a notice of 07 days.
- 4. The re-engaged employees are entitled only for monthly fixed remuneration i.e. reducing pension from his/her last pay drawn, (i.e. Basic + DA as applicable) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay drawn at the time of retirement.
- 5. The re-engaged employee will not be eligible for any kind of leave (like CL, APL, and Sick Leave etc.) For absence if any, appropriate deduction will be made from the monthly remuneration.
- 6. The duty hours of the re-engaged employees would be as per requirement. The duty hours can be changed as per the requirement of work by the administration.
- The re-engaged staff will not have any claim or right for his continuity in service or automatic extension or termination of contract.
- 8. The service condition of re-engaged retired employees will be governed by Railway Board guidelines issued from time to time.
- 9. Re-engaged staff should be discharged immediately on joining of selected candidates.
- 10. The engaged staff can be booked on ART/ARME/Road ART at a times required in emergency situation.
- 11. if certain situation demands, the staff may be booked/moved to other locations as per the direction of Sr. DME/SUR Office.
- 12. Staff will also be governed by the policy guidelines and direction by the Sr. DPO/SUR Office in reference to re- engagement employees.
