- 01) This re-engagement is to be reviewed at the interval of every year effective from 1st January of the year.
- 02) The scheme is valid up to 01.12.2019.
- 03) The administration is at liberty to terminate the services of the re-engaged employees even before 01.12.2019 in case their work/Conduct is found unsatisfactory by giving a notice of 07 days.
- 04) The re-engaged employees are entitled only for monthly fixed remuneration i.e. reducing pension from his/her last pay drawn. (i.e. Basic+DA as applicable) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay drawn at the time of retirement.
- 05) The re-engaged employee will not be eligible for 08 days leave (on pro rata basis) in a calendar year as per RBE No. 118/2019 dated 24/07/2019. For absence if any, appropriate deduction will be made from the monthly remuneration.
- 06) The duty hours of the re-engaged employees would be as per requirement. The duty hours can be changed as per the requirement of work by the administration with weekly off for one day.
- 07) The re-engaged staff will not have any claim or right for his continuity inn service or automatic extension or termination of contract.
- 08) The service condition of re-engaged retired employees will be governed by Railway Board guideline issued from time to time.
- 09) Maximum upper age limit for re-engagement is 65 years as on 01.12.2019. Hence no re-engaged employee should continue in service beyond 65 years of age.
- 10) Re-engaged staff should be discharged immediately on joining of selected candidates.
- 11) Incharges will submit monthly report to Sr.DEE through SSE/M/SUR & KWV regarding their working.
- 12) Incharg will keep close watch on their day to day working.
