entitled for pay fixation on their regular promotion as it is the same grade granted under MACP in reference to para 4 of annexure of Railway Board's letter no.PC-5/2009/ACP/2 dated 10.06.2009.

Transfer of a Railway servant, ordered as a result of his promotion should be carried out by the employee as early as possible in his own interest. In the case of an employee who neither gives the refusal in writing nor joins duty on being promoted, it should be treated as refusal of promotion and action taken accordingly.
