In terms of Rly Board's letter No 2004/ M(L)/466/7101 dt.31.08.2009, the procedure laid down regarding standardized system for Loco handling training to the ALP/Shunters before promotion as Loco Pilot Goods should be adhered to ALP/Shunters promoted as LP (Gds) should be kept under supervision of CLIs.

Sr. No.16 & 21 are promoted against UR point will be set off against SC point in future vacancy.

Sr. No. 19 & 24 is promoted against UR point will be set off against ST point in future vacancy.

Special Note-

Fixation of Pay will be done as per extant rules on the subject. Employee is eligible to exercise an option within a period of a month for fixation of pay on promotion in the manner as laid down in RBE No. 79/2017 dt. 31/07/2017.

Fixation of pay of promoted LP(Goods) will be done after obtaining the Competency Certificate from Sr. DME.

The above promotion order is provisional and subject to the conditions that there is no DAR/SPE/Viz case pending or contemplated or proposed to be initiated. The above promotions are subject to result of Supreme Court/ High Court/ CAT decisions.

The promotion is also subject to disposal of writ petitions / appeals / applications pending in various courts as the case may be in occupation before carrying out the transfer/ promotion order.

All the promotions shall be subject to outcome of the main SLPs & contempt petition mentioned in the railway Board's Lr. No. 2016-F(SCT)1125/8 dt.30/09/2016 (RBE No.117/2016) & as per instructions of HQ Lr. No. P/HQ/Ruling /O/817 dt. 04.10.2016 & clarification of HQ's Lr. No. P/CR/HQ/RP/601- Policy dt. 15/03/2017.
