The above candidates are nominated for field training under SSE/Sig./SUR & SSE(Tele)SUR till further instructions.


They have fulfilled the following conditions and directed for training.

- 4) Executed Agreement Bond on the prescribed form to serve for a period of 05 years in the Railway Administration faithfully and efficiently. In case they are leaving the Job/ Appointment, they have to refund the stipend plus training cost and 12.1/2% P.A interest thereon.

They will be governed by New Pension Scheme in terms of Rly Bd's Letter No. F(E) 2003/PNI/24/dated 31/12/03 & 2002/AC II/21.1 dated 27/02/2004 to contribute 10% of his pay + dearness allowance for the New Defined contributory scheme.

On resuming/reporting training they will be paid stipend @ Rs. 19,900/-+DA as admissible and their further posting for field training will be issued separately.
