All the promoted employees are eligible to exercise an option within a period of one month for fixation of pay. Who have already awarded higher grade under MACP scheme are not entitled for pay fixation on their regular promotion in reference to para 4 of annexure of RB's letter No.PC-5/2009/ACP/2 dated 10.06.2009. The date of shouldering higher responsibilities along with option for fixation of pay, if eligible, should be forwarded to this office immediately for timely fixation of pay.
