In terms of para 224 of IREM Vol I I i) The employee refusing promotion expressly or otherwise (i.e. that he does not give in writing his refusal but also does not join the post for which he has been selected) Such an employee should be debarred for future promotion for one year but not be transferred away from that station for one year if unavoidable domestic reasons exist. All promotions shall be subject to outcome of the main SLPs and the contempt petition mentioned in the Railway Board's letter No. 2016-E(SCT)1I25/8 dated 30/09/2016 (RBE No.117/2016) and as per instructions of HQ letter No.P/HQ/ Rulinf/O/817 dt.04/10/2016 and clarification of HQ's letter No.P/CR/HQ/RP/601-Policy dt.15/03/2017 and in terms of Railway Boards letter No.2018-E(SCT)I/25/9 dt.19/06/2018 circulated by CPO/CSMT vide letter No.P/HQ/Ruling/O/817 dt.21/06/2018.
